CURRICULUM CHANGES

Resolved, that the following curriculum changes, as recommended by the Academic Senate and the Officer in Charge, be, and hereby are, approved:

A. SCHOOL OF BUSINESS AND LIBERAL ARTS

1. EDUCATION AND SOCIAL SCIENCES

New Course Proposal:

• HIST 204 - History of the Middle East

The department is adding a new course. *History of the Middle East* was offered in prior semesters as I and II. Offering one course will better serve students.

Change to Existing Program/Certificate Proposal:

• Individual Studies, A.S.

The department is making updates to the Individual Studies, A.S. program including a change to the degree requirements. See the following examples:

<u>Current:</u> Currently the requirements are for the SUNY General Education category and LAS category. Proposed: Remove the LAS category.

Reason for Change: SUNY General Education requirements are for 30 credits within selected categories. An A.S. degree requires 30 credits of LAS courses, but no categories are specified. For example, HIST 100 is a SUNY General Education Humanities & World History Global Awareness course but a NYSED LAS Social Science due to the differing definitions across NYSED and SUNY.

<u>Current:</u> English Elective Proposed: Require ENGL 101

Reason for Change: "English Elective" to ENGL 101. Most students are currently taking ENGL 101 and the program is better served by clarity in this recommendation.

<u>Current:</u> Restricted electives renamed and change order of requirements.

Proposed: Rename and reorder. See below.

Reason for Change: Clarify for students and advisors what is in the category. Move SUNY Gen Ed 4 required areas to beginning of list to prioritize.

• Liberal Arts and Sciences, A.A.

The department is making updates to the Liberal Arts and Sciences, A.A. program including a change in program title, a change in the entrance requirements, and a change to the degree requirements.

2. FINE ARTS, THEATRE ARTS AND DIGITAL MEDIA

Change to Existing Course Proposals:

• ARTS - 220 - Painting I

ARTS 120 Painting I will have better transfer ability if renumbered to ARTS 220, to reflect the level of difficulty of the course content.

• ARTS - 221 - Painting II

ARTS 121 Painting II will have better transfer ability if renumbered to ARTS 221, to reflect the level of difficulty of the course content.

ARTS - 225 - Experimental Drawing in Italy I

Students in the Fine Arts A.S. program are expressing interest in taking ARTS 225. This course would provide a month long, hands-on immersion in the sites and masterworks of the Florence Renaissance exploring the interface between historical and contemporary drawing.

• ARTS - 226 - Experimental Drawing in Italy II

Students in the Fine Arts A.S. program are expressing interest in taking ARTS 226.

• ARTS - 229 - Photography II

ARTS 139 Photography II will have better transfer ability if renumbered to ARTS 229, to reflect the level of difficulty of the course content.

• <u>DART - 215 - Video Art</u>

DART 115 Video Art will have better transfer ability if renumbered to DART 215, to reflect the level of difficulty of the course content.

New Program/Certificate Proposal:

Health Science, A.S.

The purpose of creating the Health Science Degree program is to give students the opportunity to collect pre-requisites necessary for application to the competitive health science programs and increase transfer opportunities. Additionally, having a degree along with the certificate will allow transfer students the ability to matriculate in a relevant program instead of matriculating into a program just for the sake of matriculation/financial aid eligibility.

C. SCHOOL OF STEM

1. BIOLOGY, CHEMISTRY AND PHYSICS

Change to Existing Program/Certificate Proposal:

Biotechnology, A.S.

The degree requirements In the Biotechnology A.S. program are changing by replacing one course for another, the change is from FORM 101, College Forum, to BIOL 103, Orientation to Biology and Bioethics. This change will better serve the students in the Science program because BIOL 103 introduces students to the Hudson Valley Community College campus and to biotechnology as a field of study. This course will also focus on the ethics and bioethical issues of biotechnology.
