To receive a Pell Grant award during the summer semester a student enrolled in less than 6 credit hours must have remaining eligibility for the 2018-2019 aid year. If enrolled in 6 degree-applicable credit hours, a student may qualify for additional Pell Grant funds over the 2018-2019 yearly limit. *All payments of Pell reduce a student’s remaining lifetime Pell limit.

*Students will automatically be considered for summer Pell awards based on registration status. If a student does not wish to receive a summer Pell award, they must notify the Financial Aid Office in writing. Additional information can be found at www.hvcc.edu/catalog/financialaid.

To receive a summer Federal Direct Subsidized/Unsubsidized Stafford loan a student must:

1. Have not already received the maximum loan amounts for the 2018-2019 aid year. Awards received at other institutions must be considered.
2. Submit a complete Federal Direct Summer Loan application. Complete an Electronic Master Promissory Note and Entrance Counseling online at www.studentloans.gov, if not already on file with the Financial Aid Office.
3. Register for and complete a minimum of 6 degree-applicable credit hours.

To receive a summer Federal Direct PLUS loan a student must:

1. Register for and complete a minimum of 6 degree-applicable credit hours.
2. Have their parent complete a PLUS loan application and an Electronic Master Promissory Note online at www.studentloans.gov, if it is not already on file with the Financial Aid Office.

Financial Aid Eligibility Requirements

Read the Eligibility Requirements below to determine whether you qualify for summer aid. If you do not meet the conditions listed below, you are not eligible for summer federal financial aid. If you have questions, please contact the Financial Aid Office for clarification at (518) 629-7150.

- I have a 2018-2019 FAFSA on file with the Financial Aid Office.
- I am in an eligible degree program (matriculated) for summer 2019.
- I have scheduled summer 2019 courses that are applicable to my degree.

Step #2: Certification & Signatures (Read, Check & Sign)

- I understand Satisfactory Academic Progress will be measured for spring 2019 in late May. If I did not successfully complete my spring 2019 semester I may not be entitled to summer federal aid. If I lose my eligibility, I will be responsible for any outstanding tuition balance. I will also contact the Financial Aid Office for advisement regarding how to regain eligibility.
- I understand that I will be measured for Satisfactory Academic Progress at the end of the summer term. Failure to successfully complete my summer term may result in the loss of financial aid for the fall 2019 semester as outlined in the college catalog. I must register for and complete at least 3 degree-applicable, non-remedial credit hours during summer in order to maintain eligibility for the fall 2019 semester.
- I certify that the information I have provided on this application is true to the best of my knowledge. I understand that I must immediately notify the Financial Aid Office in writing of any change in my summer registration as it may influence my eligibility for summer financial aid and future financial aid.
- I must regularly participate in my class(es). If I withdraw from, or stop participating in, all of my summer courses my financial aid will be recalculated and I may owe a repayment of financial aid and/or balance of my tuition and fees.
- I must not exceed the maximum timeframe for completion of my degree requirements (150% rule) as outlined in the college catalog.
- I understand that my summer aid may not be processed in time for a financial aid deferral. I understand that in order for me to become registered, I must be prepared to pay my summer tuition bill.
- I may not be eligible for summer federal aid if I have already exhausted my 2018-2019 eligibility.
- I understand financial aid will not cover my summer book expense and I am solely responsible for purchasing my books for the summer semester.
